Justin City Council Regular Session Meeting-January 30, 2017

The Justin City Council Meeting convened into a Regular Session being open to the public the 30th day of January, 2017 at 7:02 p.m. in the Council Chambers of Justin Municipal Complex, and notice of said meeting giving the time, place, date and subject there of having been posted as prescribed by Article 5 of the Texas Government Code, with the following members present and in attendance to wit:

Invocation and Pledge of Allegiance by Councilmember Eric Priddy.
